Wherefore Art Thou, Perio?

THE WAY WE WERE. As you can see in this early photo of our dental school building, before the 1962 and 1972 sections were added to the back of the original 1933 structure, the entire school was not much deeper than the "main clinic" itself – the bank of windows on the narrow balcony at upper left represents the building's back wall. Since 1992, the main clinic has been home to 3 sections of the 3rd floor's Comp Care system. We're used to looking up from Comp Care at the big glass windows belonging to the Periodontics and Allied Dental Programs on the 4th floor, but in the 1930s the slim balcony space was home to a ceramics department. Most of the school's adult patients were treated in the one big clinic seen here; clinics for child patients and oral surgery were housed directly below the main clinic, along the north side of the 2nd floor hallway where Oral Biology labs and Faculty Practice are today.



IUSD TO COLLABORATE WITH KING SAUD UNIVERSITY COLLEGE OF DENTISTRY. In a public ceremony at the April 2013 International Exhibition and Conference on Higher Education in Riyadh, Saudi Arabia, IU Vice President for International Affairs **David Zaret** and King Saud University President **Badran Al-Omar** signed documents formally launching a collaboration between the two universities.

Early in 2012, a delegation from the College of Dentistry at King Saud University, one of Saudi Arabia's leading universities, visited Indiana University-Purdue University Indianapolis to explore a collaboration with the IU School of Dentistry. They had two primary goals in mind: create a joint PhD program between the two schools and provide a pathway by which junior and aspiring faculty at King Saud

University could attend IU specialty clinical programs as visiting fellows before applying for acceptance into one of the programs.

Key to these discussions were, from King Saud, Adel Al-Hadlaq, vice dean for academic affairs, and Ibrahim Al-Harkan, dean of graduate studies; and, from IU, **Michael Kowolik**, associate dean for graduate education and global engagement, and **Richard Gregory**, director of student research and the PhD program at IU School of Dentistry.

With two advanced degrees from IU School of Dentistry, **Nawaf Yousef Labban** of Saudi Arabia served as a catalyst in forging the new relationship.

A formal invitation from the Saudi Arabian Ministry of Higher Education for IU to participate in its April higher education conference presented the ideal opportunity for a reciprocal visit to King Saud University to move the collaboration toward a joint PhD forward.

According to Dr. Kowolik, "The initiative Dr. Labban has developed provides the IU School of Dentistry with a platform and impetus for launch of a unique collaboration with a Saudi institution of prestigious standing. We hope that we are paving the way for other IUPUI and IU schools and programs to follow."

PROSTHODONTICS PROF, STUDENT, AND STAFF MEMBER RESTORE A HOSPITAL PATIENT'S SMILE.

Removable dental work, unlike its fixed counterpart, has a lot in common with rings, watches, eyeglasses, and other small personal belongings: It can easily be misplaced in hotel and hospital rooms or for that matter anyplace people wind up staying that's outside of their normal routine and comfort zone.

When a denture went missing recently for a patient at an Indiana hospital, the hospital turned to the IU School of Dentistry for assistance – and found that excellent help was in ample supply in Restorative Dentistry, where a 3-member team instantly went about the business of providing 5-star service to the distressed patient.

Dr. **John Levon**, director of the graduate programs in prosthodontics and maxillofacial prosthetics, responded promptly to the urgent request and immediately put a patient-care plan in motion. He arranged for the patient to work with graduate prosthodontics coordinator Ms. **Tangela Williams** as well as maxillofacial prosthetics resident Dr. **Anthony Kight**.

SUSAN ZUNT TO BEGIN A 7-YEAR JOURNEY LEADING TO PRESIDENCY OF NATIONAL ORAL PATHOLOGY BOARD. An election during the American Academy of Oral and Maxillofacial Pathology annual session in Portland, Ore., in June, has set Dr. **Susan Zunt**, chair of Oral Pathology, Medicine, and Radiology, on a long path that will culminate in a prestigious leadership position for her in America's national dental community.

She has been elected the director designate of the American Board of Oral and Maxillofacial Pathology, an 8-year position that will commence in October 2013 at the close of a meeting in Tampa, Fla., where she will join the 6 other specialists who have previously been elected to the board (one each year).

The directors have demanding roles to fulfill on this highly respected specialty board, which is charged with the duty of determining certification and re-certification of eligible individuals for oral pathology practice by examination and credentials maintenance.

Before Dr. Zunt can join her colleagues as a board director, she must first take the re-certification examination herself at the Tampa meeting. She will then spend the entire first year of her service as an observer of the board as she gets thoroughly acquainted with its processes. In the fall of 2014, she will begin 6 years as an active board member, and in the 8th and final year of the directorship, in 2020, she will serve a one-year term as ABOMP president.

"I was honored to be nominated and now am doubly so to have been elected to serve as director of the ABOMP," says Dr. Zunt. "I am looking forward to serving both my specialty and the dental profession."





NIH GRANT COMES ON THE HEELS OF AN IADR YOUNG INVESTIGATOR AWARD. He came to our faculty just three short years ago as a new PhD graduate in Materials Science of The University of Alabama at Birmingham (UAB School of Engineering), but Dr. Marco Bottino of the Dental Biomaterials division of Restorative Dentistry has made an impressive transition from student to clinician/scientist in the research community. In March Dr. Bottino received a Young Investigator Award in the basic research category at the 2013 Satellite Symposium of the International Association for Dental Research's Pulp Biology and Regeneration Group, held at the Arthur A. Dugoni School of Dentistry in San Francisco. Dr. Bottino worked on the award-winning project, titled "Biodegradable Nanofibrous Drug Delivery Systems for Root Canal Disinfection," with his IUSD co-authors Drs. Krzysztof Kamocki, Ghaeth Yassen, and Jeffrey Platt of Dental Biomaterials; Dr. Richard Gregory of Oral Biology; and Drs. Mychel Vail, Ygal Ehrlich, and Kenneth Spolnik of Endodontics.

And now Dr. Bottino has received confirmation that he is the recipient of a 5-year, \$715,525 grant from the National Institute of Dental and Craniofacial Research of the National Institutes of Health (award number K08DE023552). During the 2013-2018 project period, Dr. Bottino will study a novel multilayered membrane for periodontal regeneration. Watch for more details about Dr. Bottino's new grant coming a bit later this summer.

In addition to his PhD, Dr. Bottino holds a dental degree from Universidade Paulista (UNIP) and a master's in Nuclear Technology/Materials from Instituto de Pesquisas Energeticas e Nucleares (IPEN), both in São Paulo, Brazil.

BREAK-THROUGH PROCEDURE ECHOES EXCITEMENT FOR COCHLEAR IMPLANT 30 YEARS AGO. In recent weeks a video clip has been circulating in the news that shows a 3-year-old deaf youngster as he hears his daddy's voice for the first time, thanks to an experimental implant stimulating his brain.

This wonderful moment in medical research – and in one child's life – is reminiscent of news clips of children reacting to the cochlear implant in the 1980s. The cochlear implant was the invention of Dr. William House, a University of California-trained dentist who went on to become one of the world's most famous ear researchers. According to a *New York Times* report, in addition to inventing the cochlear implant he developed a surgical procedure that enabled **Alan B. Shepard Jr.,** the first American in space, to travel to the moon without suffering vertigo-like symptoms.

William had ties to our school – he was the son of Dr. **Milus House**, one of our legendary alums and professors and one of America's pioneering inventors in dentistry. After graduating from the Indiana Dental College in 1903, Milus served for a few years on the college's faculty before eventually moving west and becoming a noted and highly successful inventor of dental articulators, casting machines, and anterior tooth molds. Milus was one of the co-founders of the American College of Dentists and the Pierre Fauchard Academy.

William, like his father Milus, put service for the public good above personal profit. He purposely did not patent his inventions so that other researchers could have access to them, just as Milus turned down the opportunity to receive royalties from the millions of copies of tooth molds made from his originals.

LAURA ROMITO TO PLAY KEY ROLE IN NEW INTERPROFESSIONAL CENTER AT IU. Oral Biology professor Dr. **Laura Romito** has accepted an appointment as one of 3 associate directors of the new IU Center for Interprofessional Health Education and Practice.

Led by director Dr. **Judith Halstead** of the School of Nursing, the center will strive to foster an interdisciplinary approach to health care and education by focusing on 3 major efforts: faculty development and leadership training, which Dr. Romito has been chosen to direct; curriculum development and integration; and outcome evaluation and scholarship.

In her new role, Dr. Romito will devote 25% of her time to service in the new virtual center, which gets under way this summer. Initial stakeholders include the IU Schools of Dentistry, Health & Rehabilitation Sciences, Medicine, Nursing, Optometry, Public Health (Bloomington and Indianapolis) and Social Work, and the Purdue College of Pharmacy; however, the center will seek collaboration from a broad spectrum of academic and community partners to ensure it serves as a viable resource to the university.

JEFFREY DEAN ASSUMES CHIEF OF STAFF DUTIES AS A NEWLY CERTIFIED EXECUTIVE. A few days before Dr. Jeffrey Dean began his half-time appointment as IUPUI Chancellor Charles Bantz's new chief of staff on July 1, he received word from the Certified Association Executive Commission (CAE) of the American Society of Association Executives (ASAE) that he has earned the CAE credential, which is the highest professional credential in the association industry, and a designation held by less than 5 percent of all association professionals.

Dr. Dean sat for the CAE exam in May. In addition to passing this stringent exam, CAE applicants must have acquired a minimum of 3 years' experience in nonprofit organization management and completed at least 100 hours of specialized professional development.

Dr. Dean's long record of leadership service to Indiana University and its dental school is complemented by the many roles he has played in the dental community, including his current 5-year appointment as executive director of the American Board of Pediatric Dentistry.

The ASAE is a membership organization of more than 21,000 association executives and industry partners representing 10,000 organizations throughout the U.S. and in about 50 other nations.

THE MAN WITH THE PLAN, THE MAN WITH THE PURSE, THE MAN WITH THE POWER: CORRESPONDENCE OF AN ARCHITECT, A BURSAR, AND AN IU PRESIDENT GUIDED THE BUILDING OF OUR SCHOOL. As we move deeper into the campaign for our new clinical and research facilities, it's interesting to take a look back at the original building project at our school's current site from 80 years ago. We moved to 1121 W. Michigan in 1933, after dwelling in various downtown buildings – 5 altogether – between 1879 and 1933.

We've stumbled upon a collection of letters archived by IU between IUSD architect **Robert Frost Daggett** and others who gave shape and substance to the original 1933 building, including primarily IU President **William Lowe Bryan** and University Bursar **U.H. Smith**.



The dental school's architect, **Robert Frost Daggett**, also designed Long Hospital. In this 1914 photo, dignitaries gathered for Long's dedication ceremony. Two decades later, the 3 men seen at far right in this photo would write many letters back and forth to one another to deal with the day to day business associated with the construction of the dental school: At right in the front row is legendary IU President **William Lowe Bryan** (presiding 1902-1937); behind Bryan is architect Daggett; and on the top step at the far right is University Bursar **U.H. Smith**.

It's difficult to stop reading these letters – each representing a unique moment in our history – once you get started.

There's a clue, for example, about how those rather homely, utilitarian yellow bricks may have wound up covering the external walls of our school's first major addition, now known as the 1962 middle section.

As a money-saving move in the 1930s, the back wall of our 1933 limestone building was covered with buff-colored brick instead of limestone. Remember, there was no IUPUI campus back then, so the back of our building was private, off the beaten path, and completely out of view to the public.

Nevertheless Daggett, in his wisdom as one of Indiana's most talented architects, was concerned that future growth in the area could result in the back wall being exposed to the public eye, and therefore he wanted it to clash as little as possible with the limestone. Common red brick had been recommended for

the back, but Daggett pushed for the buff-colored brick because it blended with the limestone much better.

Of course, Daggett couldn't have foreseen that folks would come along 3 decades later to build the 1960s addition onto his original building – and that they would decide to cover this large second facility in buff brick to match the plain back wall of the 1933 structure rather than to cover it in limestone to match 1933's beautiful face.

By the way, when Daggett's baby son grew up, he joined the firm and served as the architect for our school' major 1972 limestone addition. Robert Jr. built the back section of our school as a handsome contemporary partner to his father's 1930s structure. To appreciate the complementing father/son designs, though, you kind of have to train your eye to skip over the building's hulking yellow middle section.

What's most fascinating about these quaint letters is that they reveal how thoroughly involved IU President Bryan was in the process every step of the way – an indication of just how compact IU was in those days. In one exchange, Daggett has to ask the president for an extra \$98 to make a change after IUSD Dean **Frederic Henshaw** informs Daggett that the dark rooms are letting in too much light. In his reply, Bryan sounds mildly annoyed by the request for more money, but acknowledges that light leaking into a dental dark room is a problem and therefore promptly authorizes the extra expenditure. The letters also show that the architect was held in high regard by the president – they worked together on many IU building projects.

My dear Dr. Bryan:

I have just received a request from Dean Henshaw to send you the plot plan of the proposed site for the Dental School south of Michigan Street.

The tracing of this site was left at Bloomington last Friday and I have no copy of it in the office.

I am, however, sending the complete layout of the buildings at the Medical Center, which shows the proposed site south of Michigan Street.

If this does not meet your needs and you do not find the tracing, I will be glad to get the original plot plan from Mr. Dyer and make another tracing for you.
