#### Announcements from the Chair

- The new College Scorecard was recently released. http://collegecost.ed.gov/scorecard/index.aspx
- The Scorecard presents a standardized way to compare different institutions on cost, graduation rate, loan default rate, median borrowing amount, employment. We need to be aware of the availability of such systems and know that families will be using them.
  - With their availability on the Scorecard and related tools, graduation rates will become even more public. In addition, Indiana's performance funding also considers the number of graduates within four years. We have to get our rates up.
  - Our loan default rates will likely be going up in part due to what has been happening in the economy.
  - A default management partner is being considered for the IU system. This is a vendor to help better track the borrower and help more with collections than our current approach allows.
  - o Institutions with higher admission standards also tend to draw students from families with higher income and a lessened need to borrow. This is one more factor in seeking an appropriate balance in setting our standards and maintaining our mission of access.
  - Our costs are low, but our borrowing rate is in the median in the Scorecard. We have more students who are Pell eligible. One interesting item is that IUB students borrow more money than IUPUI students.

- Communications sent to students about enrolling for Summer
  - The communications designed by the IU Office of Communications and Marketing will be sent on 4/12, 4/19, and 4/26. See <a href="http://summer.iu.edu">http://summer.iu.edu</a> for the website they designed.
  - The IUPUI Registrar sent information on 4/10 to encourage students to enroll for summer either at IUPUI or at another IU campus if they are returning home for summer.
  - Communications have been sent to IUB students whose home addresses are in central Indiana inviting them to enroll in summer courses at IUPUI.
  - o IUPUI admission staff members were at Purdue West Lafayette to enroll students who were coming home to the Indianapolis area for the summer.
  - Anything that the schools can do to encourage their students to re-enroll would be most welcomed.
  - In addition to the tuition cost in the current economy, we know that one factor in our enrollment situation is the result of changes in the state's teacher licensing requirements that has resulted in lower enrollments in the School of Education. Members were encouraged to let Becky know of any other factors that may affect students in their units.
  - A mailing will go out from Student Financial Services to encourage students to check with SFS about any summer aid possibilities.

- Fall enrollment looks good; Orientation not yet underway for fall beginners, though appointments are ahead of last year.
- Enrollment deposits are ahead of last year, but we are taking that with a bit of caution. This entering group is getting things done earlier than last year; we've also shortened our turnaround-time in processing applications, resulting in earlier admissions and notifications.
- Remember that IUPUI is piloting some 2 day orientations so we won't have easy comparisons with individual weeks in our orientation totals
- We have had three <u>Spring Preview</u> days; all were well attended and the feedback from participants very positive.
- Student Financial Services (SFS) updates
  - SFS has a new look and additional information on its website http://www.iupui.edu/~finaid/
  - Loan debt communication to continuing students
    - A letter will be sent in early May to all students who have borrowed to inform them of their individual cumulative loan debt and the repayment amount.
    - The mailing will encourage students to think about how much debt they are taking on and will include links to helpful information.
    - While the letter will include a total of all loan debt taken on while enrolled at IUPUI, the letter also will provide a link to the national student loan data system for students who want to look at their total student loan debt if they had borrowed while enrolled elsewhere.
  - o Change in Student Loan Processing to Active Loan Acceptance
    - Beginning Summer term 2013, all IUPUI students will be required to either Accept, Reduce or Decline the Stafford loans that appear in students' Financial Aid Notification and in students' OneStart accounts. It is very important for students to monitor OneStart and "Accept" or "Reduce" Stafford loans that they wish to receive. If no actions are taken, the Stafford loans will **not** be disbursed, the reverse of how things have been done in the past.
    - This brochure will be sent out to students along with their award letters
    - SFS is encouraging students to follow Twitter feeds.
    - EMC members were encouraged to make advisors in their units aware of this change to "active loan acceptance" and mention this to their students.
    - For students who do not take action earlier in the summer, the bill likely will prompt the student to take the necessary acceptance step (that is, the *absence* of a loan credit appearing on the bill will get their attention).

  - o As of mid-April SFS has sent out 800 more award letters than last year.
- Evidence-Based Credit Assessment (prior learning assessment)
  - The need for more Evidence-Based Credit Assessment came up in a number of <u>reports</u> of the IUPUI 2025 task forces.
  - In moving to a broader adoption of such a model, we need to determine the necessary and most efficient administrative that would also allow ease of submission and as well as a tracking mechanism.
  - Such assessment comes through multiple paths. It could be through a student's portfolio, credit by examination, a credential awarded by some recognized organization, or the military. In the case of externally awarded credential, we want to take those decisions made by the faculty and put them into a database so that future students who present the

same information can receive the credit automatically through routine processing in Admissions, much in the way it works for transfer credit from new institutions.

- This is not a matter of Admissions making the determination; the initial evaluation is done by the faculty.
- We are currently working through some what-if scenarios based in the SIS. We hope to have a proposal for a structure ready for review and comment in the fall.
- Once established we can get the word out to our students who qualify and demonstrate those cases where they have met the learning outcomes.

#### • <u>IUPUI 2025</u> Strategic Plan Update

 Each Task Force developed recommendations for Strategic Initiatives. The following were submitted by the Enrollment Management Task Force along with our detailed report

#### **Optimize our Enrollment Management**

- IUPUI will improve campus-wide communication and coordination of enrollment planning and will create and use a strategic enrollment management plan to expand our reach, optimize enrollments, retain students, and increase degree attainment.
- Implement strategic, anticipatory enrollment management and coordinated enrollment planning to meet quantifiable goals for student recruitment and student success. This implementation will translate into meeting a number of specific enrollment management-related targets:
  - Increase the Indianapolis campus undergraduate, graduate and professional enrollment to 35,000 students.
  - Increase the number of degrees awarded to 7,500 total degrees granted in AY 2025-26 (4,800 baccalaureate; 2,700 graduate/professional).
  - Shorten the length of time necessary to complete an undergraduate degree.
- Establish a Division of Enrollment Management
  - Led by the senior administrator charged with the responsibility, authority, and accountability for implementation of the campus's enrollment planning and management activities
  - Incorporating both recruitment and retention strategies
  - Supported with the campus policies, processes, and data infrastructure necessary to accomplish the campus and academic unit goals

- Enrollment Services is different than Enrollment Management. Our Enrollment Services
  organization has evolved and working with other units is moving into an Enrollment
  Management perspective.

## CRM updates

- Change in Lifetime Engagement components & CRM positions
- CMC (the vendor for our CRM product; formerly Talisma) was not able to develop the next generation product that would provide the full range of service for dealing with an individual from suspect-> donor. Given its tight time frame and deadlines, the IU Foundation is looking at new vended product that will meet its specific needs.
- In order to support continued CRM implementation we have added two positions within Enrollment Services. One is a technical analyst, one is a functional analyst and they approach implementation from different perspectives. One hire is completed; we will start within ES to get them trained and then move to help schools learn how to use the tool.

- Coding Academic Advising Reports (AARs)
  - With a limited amount of support available from the Registrar's office, schools have been responsible for coding their requirements.
  - Now that we have Gen Ed code going in and the curricula being revised to meet the 120 credit ceiling, we know we have to modify the AARs. We have received special funding to support two temporary positions for two years to work with units to do the coding, but ideally in a more consistent fashion.
  - Transfers pose additional challenges in terms of AARs.
  - We are looking at ways to integrate the information in the AAR with communications via CRM. For example, we know there are students in UCOL who have completed or are close to completing requirements to be eligible for certification to a degree-granting unit.
     Automating communication to the students will facilitate the process to moving the student into the degree granting unit.
    - We are starting a pilot with PETM. Once the process is in place it can then more easily be replicated for other schools, tweaked as needed.

#### **Undergraduate Admissions Update and High School Recruiting Activities** *Chris Foley*

- Summer/Fall Admissions Update
- The numbers are looking good. See attachment below with 4/29 data
- Area High School Recruitment
  - We encourage schools' involvement in attending school-based college fairs, but want to make sure these efforts are coordinated. Please let Admissions know your plans.
  - Though it is important for IUPUI to have a consolidated presence at college fairs, we are always appreciative of faculty and/or students who would like to volunteer at our tables and speak with prospective students to share their experiences. If you have faculty or students who would make excellent representatives, please let us know, and we will reach out to them to see if they would like to join us.
  - Though our policy is to attend every fair to which we are invited in the nine-county region, we are not always informed of/invited to fairs. If you or your colleagues become aware of a fair, be sure to let us know about it. With the growth in Charter schools we especially need your help.
  - o If faculty/staff parents would like to make sure that we are invited to fairs, be certain to tell them they should contact their high school guidance office and principal's office and request that we receive an invitation. Though we can (and do) reach out to schools, we do not always receive invitations. Parents are oftentimes more effective than we are in getting us invited. Even If the fair has passed, we can push for inclusion next year.
  - A list of Admissions' recruiting efforts in the nine-county region is attached below.
     Upcoming recruiting events appear on the Admission website Jags on the Road.
    - We are getting into more and more schools, including the selective privates.
    - If schools have alumni in who would be interested in helping out at any of these events, please let Admissions know.
    - We want to provide them with information and training as IUPUI is not the institution it was when they were students.

#### **Demonstration of new Point-in-Cycle website** Gary Pike

The new PiC is part of the larger student tracking system being developed with UITs. Our hope
is to provide additional tables to what are now available. The new system will allow greater
flexibility in detailed reports and in producing ad hoc reports.

- IMIR has found that Block Enrollment class credits are not equal to the credits within the blocks. Schools are encouraged to check their blocks for accuracy and let IMIR know if there is a problem.

- The site now works well with Macs using Safari.
- There are some firewall problems in using PiC from an off-campus location, depending on the service provider. VPN works fine.
