## LEGISLATIVE REPORTS IV

The Indiana State Chamber of Commerce has published a Legislative Report comparing State Budget Committee recommendations to the General Assembly on the levels of funding for state programs during the 1973-75 biennium. The following table compares requests and recommendations on a percentage basis.

## LEGISLATIVE ACTION -- NEW BILLS

### House:

- HB 1169 - (Dorbecker, Bales) -- Would require physicians and laboratories to report existence of cancers and malignancies to State Board of Health. Amended and recommended for passage by Public Health & Environmental Affairs committee.
- HB 1175 - (Coleman, Mahoney) -- Would allow State Board of Health to set standards and requirements for all emergency ambulance services after 1 Jan. 1975. Referred to Public Health & Environmental Affairs committee.
- HB 1195 - (Doyle) -- Would lower to 18 minimum licensing age for such professions as accountants, health administrators, nurses, optometrists, pharmacists, physical therapists, psychologists, and others. Referred to Judiciary committee.
- HB 1198 - (Peterson, Bell) -- Would create an administrative unit for professional licensure in State Board of Health. Referred to Public Policy committee.
- HB 1200 - (Lamkin) -- Would establish IUPUI as independent state university with 11-member board of trustees. Assigned to Education committee.
- HB 1225 - (Hric, Jones) -- Would set 25-year minimum sentence for persons convicted of producing, selling, administering, dispensing, compounding narcotic drugs; would permit no parole. Assigned to Courts & Criminal Code committee.
- HB 1243 - (Kearns, Thomas) -- Would lower to 18 minimum age for consenting to medical treatment without approval of parents or guardians. Assigned to Judiciary committee.

HCR 11 - (Kearns, Thomas) -- Would lower to 18 minimum age for admission to the Bar.  
Assigned to Judiciary committee.

Committee Action:

- HB 1109 -- Would permit college and university guards to participate voluntarily in law enforcement training programs. Amended and recommended for passage by Public Safety Committee.
- HB 1134 -- Would permit persons 18 and older to be parties in civil suits and to appear in court without guardians. Recommended for passage by Judiciary committee.

New Bills -- Senate:

- SB 92 - (Helmke) -- Would provide immunity from civil suits to certain persons giving cardiopulmonary resuscitation. Assigned to Judiciary committee.
- SB 102 - (Helmke) -- Would create an Indiana paraprofessional health personnel education commission with accreditation powers; would appropriate \$60,000. Assigned to Public Health committee.
- SB 129 - (Shawley) -- Would require state agencies to pay overtime wages to employees. Assigned to Benevelont and Penal Institutions committee.
- SB 150 - (Bosma, Ullrich) -- Would appropriate \$3 million to establish program for education and recruitment of family practice physicians in Indiana. Assigned to Public Health committee.

#### GRANTED

Indiana's colleges and universities received \$10,176,132 during the 1972 fiscal year in research grants from the National Institutes of Health, the principal Federal agency supporting basic research in the medical sciences.

Most of this went to the four major centers for basic medical research in Indiana: The Indiana University Medical Center, \$3.9 million; Purdue University at West Lafayette, \$3.7 million; Indiana University at Bloomington, \$1.8 million, and the University of Notre Dame at South Bend, \$.9 million.

NIH also granted \$72,500 to Indiana State University, \$37,000 to Ball State University, \$14,400 to Goshen College, and \$13,800 to Wabash College.

In all, NIH awarded \$804 million in research grants during the fiscal year. More than 25 per cent of this total went to two states, New York with \$126.6 million and California with \$117 million.

Elsewhere in the Midwest, NIH awarded \$31.5 million to researchers in Illinois, \$20.6 million to Michigan, \$21.3 million to Ohio, and \$2.6 million to Kentucky.

#### RILEY GETS SPECIAL GRANT

The National Cystic Fibrosis Research Foundation has awarded a special \$2,000 grant to Riley Hospital for Children in recognition of the "exemplary care and teaching programs" provided in Riley's referral and treatment clinic for children with cystic fibrosis and other chronic pulmonary diseases.

The clinic, directed by Dr. David Need, is the primary Indiana center for the treatment of cystic fibrosis and similar diseases. The Riley clinic currently has about 100 patients from throughout Indiana.

The award was made by the national foundation after the group's General Medical and Scientific Advisory Council completed a careful review of the clinic's programs in patient care and education programs.
