
# PRESIDENT ELDON WITT SAYS "ALUMNI SAILS NEED SECOND WIND"

# NATIONAL COUNCIL FOR VOCATIONAL AND TECHNICAL EDUCATION IN AGRICULTURE

The new National Council for Vocational and Technical Education in Agriculture held its first meeting on April 9-11 to elect officers, adopt bylaws, and identify priorities. This Council, composed of professionals from agriculture, industry, and vocational agriculture education, will provide national leadership and direction for the total vocational instruction program. Dr. Larry Case, the head of vocational agriculture programs at the U.S. Department of Education, was elected chairman. The FFA Alumni will be represented by Mrs. Shirley Davis for the next two years.

#### FFA ALUMNI CONVENTION

You are invited to attend the National FFA Alumni Convention on November 7 and the FFA Convention on November 8-10 in Kansas City, Missouri. FFA Alumni and their families will find this to be four days of exciting, educational, and motivational activities. The FFA Alumni Convention will be from 1:00 - 5:00 p.m. on Wednesday. Alumni workshops, of one hour each, on improving and organizing affiliates will be conducted Thursday morning. Over 22,000 are expected to register for the two conventions. The FFA Convention speakers already confirmed are Pat Summerall, National Sports Commentator; Art Linkletter, TV Personality; and Mamie McCullough, The "I Can" Lady. The FFA Alumni will sponsor five one-hour motivational workshops that are considered very educational. These workshops are free and normally filled to room capacity of 1,000 persons.

Dr. Larry Case, 40, state FFA advisor for Missouri, has been named Education Program Specialist for Agriculture, Agribusiness and Natural Resources Occupations in the U.S. Department of Education, National Advisor of the FFA, and National Advisor of the Postsecondary Agriculture Student Organization. He will provide leadership to vocational agriculture students and professionals in the United States and its territories.



#### 1984 ALUMNI INTERNS — ROBERT SOMMERS, OHIO AND JACKIE FORD, MISSISSIPPI

The interns serving the FFA Alumni for one month this summer will be making visits to approximately 100 key leaders in the Washington, DC, area. They will tell the story about the importance of vocational agriculture education and the FFA.

Robert Sommers is a teacher of agriculture and FFA Alumni member at the London High School in London, Ohio. He states that "the governmental affairs FFA Alumni intern program is an outstanding opportunity for me to acquire a much needed training in governmental affairs. To maintain the quality of vocational agriculture education, all individuals associated with teaching must be aware of and involved in the political aspects of funding, guidelines, and legislation. The day when teachers and Alumni could simply assume that everyone knew of the importance of a sound education is gone. We must each play an active role in telling the Vocational Education story."

Jackie Ford is a teacher of agriculture at the Pine Grove High School near Ripley, Mississippi. Jackie has served as State FFA Alumni President, Vice President of Mississippi Vocational Agriculture Teachers, and President-Elect of the Mississippi Association of Vocational Educations.

The FFA ALumni provides each intern with lodging, meal allowance, and round trip travel money to Washington, DC. We feel that this is a great educational opportunity for the individual and provides valuable public relations for vocational agriculture-FFA. FFA Alumni are requested to encourage outstanding teachers, state staff, or teacher educators to apply for 1985. Additional information is available from the national office.

#### "HIGH SCHOOLS AND THE CHANGING WORKPLACE"

The National Academy of Sciences has published a report entitled "High Schools and the Changing Workplace". Listed below are the ten core competencies recommended by the study. These core competencies are required by employers and are vital to almost every job, except the least skilled, and are essential to upward mobility and adaptability.

- 1. Command of the English Language
- 2. Reasoning and Problemsolving
- 3. Reading
- 4. Writing
- 5. Computation
- 6. Science and Technology
- 7. Oral Communication
- 8. Interpersonal Relationships
- 9. Social and Economic Studies
- 10. Personal Work Habits and Attitudes

I personally feel that vocational agriculture includes more training and development of these core competencies than any class in our public high school. A panel composed of 20 national leaders spentabout eight months preparing this report. David C. Thomas, Director of Member Services, Milk Marketing Inc. in Cleveland, Ohio and past National FFA Alumni President was the only agricultural panelist. The National Academy of Sciences has mailed 30,000 copies of this report to educational leaders including local school superintendents. We encourage your local FFA Alumni to study their vocational agriculture program and present their views to the local guidance counselors, principals, superintendents, and the school board on the values and core competencies found in the vocational agriculture program. #### WORKSHOPS FOR FFA ALUMNI

Since the 1983 FFA Alumni Convention, the National FFA Alumni has conducted workshops on how to organize and operate local and state FFA Alumni. The workshops include techniques on chartering and a proven system for developing and operating good support activities. Southern, Western, and Central Regional Council Representatives have planned workshops in Georgia, Kansas, Missouri, South Dakota, and Wyoming. State workshops have been held in Indiana, Mississippi, and Montana. The Redbud Affiliate conducted an excellent workshop for their area of Illinois. We encourage states and local affiliates to plan workshops to assist our FFA Alumni leaders in their role of developing stronger FFA Alumni affiliates. #### **EXAMPLES OF LOCAL FFA ALUMNI SUPPORT**

The Granton, Wisconsin FFA has 60 members and the Granton FFA Alumni has 120 members - just double. The FFA Alumni and FFA cooperate on a project to send cripple children to camp for two weeks by collecting oats, corn, and old batteries and resell them. This year the groups collected 100 old batteries and over a ton of grain which they resold, and along with some monetary contributions, collected \$500. The group was featured on the Easter Seal Telethon for collecting over \$5,000 the past ten years. The Alumni also sponsor a fire extinguisher day and grade school safety program in cooperation with the local FFA. Area residents can get their extinguisher cleaned or refilled or purchase a new one at a reduced price. They show films to the local grade school students and give each student a safety picture to color. Prizes are given to the best colored pictures. Along with these projects, the Alumni sponsors a rabies clinic in cooperation with the local vet clinic.

#### WASHINGTON CONFERENCE SCHOLARSHIPS

The FFA Alumni will provide 45 scholarships for the Washington Conference Program at a value of \$295 each which totals \$13,275. Scholarships are provided on the basis of one for each 500 active state FFA Alumni members, or one for each 250 active local Alumni members, or one for each 100 Life members in a local affiliate. #### VOCATIONAL EDUCATION REAUTHORIZATION

The U.S. Senate has not scheduled the vocational education reauthorization bill for floor debate and vote at the time of printing this newsletter. Bill 2341, which is the Senate vocational education bill, was approved by the Senate Human Resources Committee. However, because of other priorities, it has not been scheduled for Senate vote. Time is running out in the 1984 Senate session and many are predicting that the vocational bill will not be considered by our Senate.

Vocational education under the 1963 legislation will be continued until 1985. Much work has been generated in passing an outstanding House Reauthorization Vocational Education Bill Number 4164 this year and the development of Senate Bill 2341. We need every Alumni member to contact their Senator and encourage the passage of Senate Bill 2341. If it is not passed this year, both the House and the Senate subcommittees will have to draft legislation in 1985, and the entire process will start over.

#### SOE WORKSHOP

The FFA Alumni will provide \$1,000 toward the National Supervised Occupational Experience Workshop which is being held July 22-27 in Washington, DC. The contribution is part of the monies given to the FFA Alumni by The Ace Bolt and Nut Company. As a result of the FFA Alumni and the National Vocational Agriculture Teachers Association sponsorship, each of the approximately 200 participants will receive a free copy of the new notebook, entitled "Orientation SOE Handbook". #### OUTSTANDING AFFILIATE AWARD

The Outstanding Affiliate Award recognizes affiliates for their support to vocational agriculture-FFA. Each affiliate should contact their state Alumni leaders for application form and rules. State winner(s) must be sent to the national office by October 1. All entries submitted by a state must have ten slides and a script accompanying the application. The slides and script will not be judged but will be used in preparing a slide presentation for the outstanding affiliate awards program at the National Convention.

# FFA ALUMNI TESTIFIES BEFORE SECONDARY VOCATIONAL EDUCATION COMMISSION

The FFA Alumni presented a statement on vocational agriculture education in secondary education before the National Commission on Secondary Vocational Education in Washington, D.C. on June 5. Robert Cox, Executive Director of the National FFA Alumni, prepared and presented this testimony. After presenting the proven values of vocational agriculture, he made several specific recommendations. Some of these included: 1. That all public high school students for graduation be required to complete two or more credits of vocational education in or closely related to their chosen occupation interest area; 2. That vocational student organizations appropriated to each occupational instruction program be intracurricular to that instruction area; and 3. That appropriate and qualified state staff be in place in each state to insure quality instruction in all public high school vocational agriculture programs, including state leadership for the FFA Organization. Copies of the statement are available from the national office.

#### **BECOME AN FFA EXECUTIVE SPONSOR**
