## GRACE Care Management to be Deployed at Indianapolis VA

When Dr. Steve Counsell was named Geriatrics Section Chief at the Indianapolis VAMC in July of 2009, his responsibilities included developing a strategic plan for innovative geriatrics clinical services, education, and research. Grant funding of \$1.3 million over the next two years for

"Dissemination of GRACE Care Management to At Risk Older Veterans" is the first step in rolling out this strategic plan. Dr. Counsell and the Indianapolis VA competed successfully for this grant

funded out of the Veterans Health Administration Office of Geriatrics and Extended Care, Washington, DC under a call for proposals "To Develop/ Disseminate Innovative Patient Centered Alternatives to Institutional Extended Care."

The Geriatric Resources for Assessment and Care of Elders, or GRACE, model includes home-based geriatric assessment and care management by a nurse practitioner and social worker who collaborate with the primary care physician and a geriatrics interdisciplinary team and are guided

by 12 care protocols for common geriatric conditions. The [GRACE care management model](#) will be disseminated and evaluated in Veterans aged 65 or older who receive primary health care at the Indianapolis VA Medical Center and who are at risk for institutional extended care.

As a new service within the Geriatrics and Extended Care Service Line, an implementation team will be assembled representing the core disciplines needed for suc-

cess of GRACE—geriatrics, primary care, nursing, social work, pharmacy, and mental health. Dr. Usha Subramanian, a VA geriatrician trained in the IU Geriatric Medicine Fellowship Program, will lead the GRACE Implementation Team and serve as Medical Director for the VA GRACE Program. Dr. Dawn Bravata, Clinical Coordinator of the VA HSR&D Stroke QUERI, will help with GRACE evaluation.

Dr. Counsell adds, "Our team looks forward to implementing GRACE at the VA to inform and strengthen long-term care delivery and promote the



### GRACE Implementation Team 12-Month Objectives

- Assemble a GRACE Steering Committee to involve key stakeholders in the implementation and evaluation process, including creation of a GRACE Dashboard to assess GRACE on measures of quality, resource utilization, and costs;
- Hire and equip VAMC personnel to deliver the GRACE model;
- Customize and load GRACE protocols and care plan strategies through CPRS templates;
- Implement GRACE in at least 200 older Veterans at risk for institutional extended care; and
- Evaluate the program for GRACE model implementation, Veteran and caregiver satisfaction, quality of care, and acute and extended care services utilization.

## Dr. Weiner Named Director at IU, VA, Regenstrief Institute

IU Geriatrics congratulates **Michael Weiner, MD, MPH**, who has been named director of the [IU Center for Health Services and Outcomes Research](#), director of the [Regenstrief Institute's Health Services Research Program](#), and director of the Department of Veterans Affairs Health Services Research and Development Center of Excellence on Implementing Evidence-Based Practice, located at the Richard L. Roudebush VA Medical Center in Indianapolis.

Dr. Weiner joined the Division of General Internal Medicine and Geriat-

rics, the IU Center for Aging Research and Regenstrief Institute in 1999 and currently is an associate professor of medicine.

Dr. Weiner's professional interests are health services research, geriatrics, and health informatics. At IU Geriatrics, he founded the gero-informatics program, which has focused on leveraging health information technologies to improve the care of older adults. He investigates the effects of health information and information technology on physicians' practices and patients' outcomes. Currently he is studying the development and implementation of information systems



to promote clinical handoffs, patient-centered geriatrics care, and clinical decision support.

While Dr. Weiner's focus will be in the VA and at Regenstrief in areas of health services and outcomes research, he anticipates that his research interests will continue to include medical informatics and geriatrics.

When addressing geriatrics colleagues, Dr. Weiner noted, "My goal is to maximize the usefulness of my skills and to have the largest positive impact for our field. Part of my job and wish is to maintain and optimize collaborative efforts that will lead to advances for our patients and populations. I look forward to ongoing research collaborations with you."
