## DUERDEN NAMED HEAD OF INFORMATION SERVICES

Appointment of Noel H. Duerden as director of information services for Indiana University-Purdue University at Indianapolis, was announced Wednesday by IUPUI Chancellor Maynard K. Hine.

Duerden, 39, has been director of publications at the school since the merger in 1969. In his new role, he will coordinate publications, the news bureau and community relations functions. He replaces Dr. Jack M. Ryder, IUPUI vice chancellor, who has been interim director of university relations.

"We are fortunate to be able to go to our own staff to fill this administrative position," Chancellor Hine said. "At a time of great growth for IUPUI, it is important to build sound communications policies which are essential to quality of performance."

Duerden is a native of Idaho and has had daily and weekly newspaper experience in both news and advertising. He was assistant manager of the Purdue News Bureau in Lafayette for five years prior to coming to Indianapolis in 1969. He graduated in journalism from Northwestern University in 1958. He and his wife Ina are the parents of five children and reside on the north side of Indianapolis.

## METROS OPEN SEASON SATURDAY

IUPUI's first basketball team, the Metros, will play their first intercollegiate game when they open their season Saturday (January 22) at the Cardinal Ritter High School gym against the IU-Kokomo team. Tip-off will be 7:30 p.m.

The \$1 general admission tickets are on sale at Mrs. Zapp's office in the Union Building, at Student Services offices at the Downtown and 38th Street Campuses and at the Normal College. Tickets will also be sold at the door. (Ritter is at West 30th Street and Tibbs.)

George Dickison, head of physical education at Crispus Attucks High School and former freshman coach at Marian College, is the part-time coach of the 14-man Metro squad. Nick Kellum of the Normal College is assistant coach.

The team has grown out of the exceptionally successful intramural basketball program and includes former high school basketball stars and transfers from other colleges and universities.

The Metros also will play the Marian College B Team January 29 and February 9. Both 6 p.m. contests will be at the Marian College gym and tickets can be bought at the door.



The team also has three games scheduled away -- IU-Richmond on Jan. 28, the Taylor University B Team on Feb. 12, and IU-Kokomo on Feb. 22 -- and they will play in the IU Regional Campus tournament which opens Feb. 29. A few of the regional campuses in the IU and Purdue systems have received NCAA recognition and are playing regular intercollegiate schedules this year.

The Metros will be supported by a squad of cheerleaders and Normal College students will stage a half-time show for the game at Ritter.

#### GENETICS SERIES ON WAT 21

The first of 15 live telecasts planned by the Department of Medical Genetics on the subject of Indiana's resources for handicapped children will be aired over WAT 21 Tuesday from noon to 1 p.m. It can be seen in rooms B-16 and 119 of the Medical Science Building.

In this first program, parents of handicapped children will outline the "Needs of Handicapped Children" through a group discussion moderated by Tony Banet, Ph.D., chief of psychological services at the Midtown Community Mental Health Center.

Subsequent programs will show how the "needs" are met, beginning with the "Intellectual Evaluation of the Handicapped" on January 25. This session will be conducted by Dr. Gail Landy, assistant professor of pediatrics, Child Development Unit, and Lawrence Hartlage, Ph.D., chief of clinical psychology, Learning Disabilities Unit, Pediatric Neurology.

Although the noon-hour series is a credit course for students in medical genetics, other interested persons are invited.

Dr. Joe Christian and Dr. Ray Antley are in charge of coordinating the presentations.

LEGISLATIVE REPORTS II

SENATE -- New Bills

- SB 167 - (Benjamin) -- Would change law requiring Indiana University to provide two scholarships from each county to provide, instead, two scholarships for each representative's district. Assigned to Education Committee.
- SB 219 - (Townsend) -- Would allow physical therapy assistants with two years of experience prior to July 1, 1972, to be certified. Assigned to Public Policy Committee.
- SB 245 - (Orr, Gardner) -- Would allow for election of a graduating senior to the board of trustees of Indiana University. Assigned to Education Committee.
- SB 248 - (Gardner, Orr) -- Would allow for the election of a graduating senior to the board of trustees of Purdue University. Assigned to Education Committee.
- SB 251 - (Duvall) -- Would provide for free tuition to state universities for dependents of prisoners of war or men missing in action in Vietnam. Assigned to Public Policy Committee.
- SB 284 - (McCormick) -- Would levy a 2 per cent tax on tickets sold for college or professional athletic events. Assigned to Finance Committee.

HOUSE -- New Bills

- HB 1147 - (Deckard, O'Connor) -- Would establish a University of Southern Indiana at Evansville incorporating Indiana State University facilities. Assigned to Education Committee.
- HB 1178 - (Richardson) -- Would establish health manpower recruitment and training programs within State Board of Health; would appropriate \$100,00 for biennium. Assigned to Public Health and Environmental Affairs Committee.
- HB 1179 - (Richardson) -- Would provide free college tuition for dependent children of city police killed in line of duty. Assigned to Cities & Towns Committee.
- HB 1205 - (Hanlin) -- Would provide for establishment of community colleges. Assigned to Education Committee.
- HB 1214 - (Dorbecker, White) -- Would transfer supervision of most professional and occupational licensing boards to the State Board of Health, but would preserve individual boards. Assigned to Public Policy Committee.
- HB 1223 - (Lamkin, Voelker) -- Would provide for the subdivision of Indianapolis into "communities" to be governed by community councils elected by residents of each community. Assigned to Affairs of Marion County Committee.
- HB 1239 - (Richardson) -- Would require county welfare departments to make family planning services available without charge to all persons receiving public assistance. Assigned to Welfare & Social Security Committee.
- HB 1262 - (Voelker, P.Bauer) -- Would add certified psychologists to the professional groups for which medical and health service benefits must be paid under health and accident insurance policies. Assigned to Insurance Committee.
- HB 1288 - (Lamkin, Mills) -- Would establish the Indianapolis Mile Square as a downtown improvement district governed by an association appointed by the mayor. Assigned to Affairs of Marion County Committee.



## PUBLICATIONS BOARD APPOINTED

Chancellor Maynard K. Hine has appointed eight persons to a new IUPUI Student Publications Board with the "basic task of providing mature guidance for students in their endeavors to develop University or quasi-University publications."

He also noted that the board will serve "as a guardian of free and responsible expression through our recognized student newspaper."

Members of the board are Professor Paul Barton, Professor Raymond A. Dault and Dr. Daniel B. Wolf, representing the faculty; Lante Earnest, Ed Harless and Robert Meier, student body; Harrison Ullmann, director of the IUPUI News Bureau, and Fred D. Cavinder, professional journalist from outside the university. A ninth board member, the director of student publications, has not yet been named.
