



LEGISLATIVE REPORTS V

House -- New bills and resolutions:

HB 1071 (Bales, Bainbridge) -- New Environmental Management Act consolidates in one body all state anti-pollution agencies; creates four-member board with members to be paid \$30,000 per year; provides penalties for violation including fines and prison terms. Appropriates \$840,000 for 1971-73. Assigned to Public Health and Environmental Affairs Committee.

HB 1100 (Bales, Lesniak) -- Raises license fees for dental hygienists. Assigned to Public Health and Environmental Affairs Committee.

HB 1101 (Nelson) -- Establishes paraprofessional Health Personnel Education Commission empowered to accredit schools, charge fees, and regulate licensing. Sets penalties for violations. Appropriates \$60,000. Effective January 1, 1972. Assigned to Public Health and Environmental Affairs Committee.

HB 1102 (Donaldson, Hall) -- Eliminates collection of sales tax on blood, blood derivatives, human tissue and organs; establishes use, storage, and provision of these as a service rather than a sale of a product. Assigned to Public Health and Environmental Affairs Committee.

HB 1154 (Bales, Bainbridge) -- Establishes chronic renal disease program by creating advisory committee on renal diseases in State Board of Health. Appropriates \$500,000 for biennium. Assigned to Public Health and Environmental Affairs Committee.

HB 1156 (Bales, Zaleski) -- Changes the State Board of Examiners for the Practice of Dentistry, raises fees for license examination and renewal, varies appointment of board members, varies examination procedures. Assigned to Public Health and Environmental Affairs Committee.

Senate - New bills and resolutions

SB 51 (Hill) -- Raises to \$1,200 the maximum amount for state college scholarships and permits leave of absence for special circumstances without loss of scholarship eligibility. Assigned to Education Committee.

SB 69 (Sheaffer, Kizer) -- Creates a regulatory scheme to establish a system of community colleges, with an interim board assisted by the Superintendent of Public Instruction to precede a governing board of trustees. Assigned to Education Committee.

SB 124 (Hill) -- Amends Indiana Scholarship Act by creating a regulatory scheme to provide educational grants to college students on the basis of their financial need up to \$1,200 a year; raises maximum scholarship award; appropriates necessary funds from General Fund. Effective July 1, 1971. Assigned to Education Committee.

SB 127 (Shawley) -- Provides that courses in sex education shall not be taught in co-educational classes. Assigned to Education Committee.

Jay Smith has been appointed director of a new "Office of Minority Student Affairs --School of Medicine" by Dr. Glenn W. Irwin Jr., dean. Activities of this office will be directed toward the development of programs which will attempt to identify and encourage members of minority groups to enter the health professions. Smith, a graduate of Ball State University, is president of the Greater Indianapolis Chapter of the National Association for the Advancement of Colored People. He will assist applicants for various programs in the health professions field and acquaint student counselors, at all levels of education, with the potential career opportunities in the School of Medicine and the Medical Center. Fortner, assistant professor at the Graduate School of Social Service; Dr. Vernon H. Broertjes, director of instructional programs for the Division of General and Technical Studies; R. Martin Bruns, assistant director of the Division of Allied Health Sciences; Dr. Edward W. Shrigley, director of graduate programs; Miss Margaret H. Applegate, assistant professor at the School of Nursing; Hugh A. Wolf, dean for student services; John G. Williams Jr., registrar; and Dr. LaForrest D. Garner, associate professor of orthodontics and chairman of the Faculty Council Commencement Committee. Two students are to be appointed as members of the IUPUI committee.

FLOWER PEOPLE & OTHERS -- Two non-credit courses in flower arrangement and design are being offered at IUPUI 38th Street Campus next semester. One is a professional floral design training course called Basic Floral Design. Designed to prepare students to work in retail flower shops, the class is held for eight Mondays and Wednesdays from 7 p.m. to 9:30 p.m., beginning February 1. The other flower course, called Flower Arrangement, is more informal. It's a six-week, Tuesday night course starting February 1.

HELP FOR PARENTS OF POOR READERS -- Parents of children with learning disabilities may be interested in two non-credit courses at 38th Street. Helping the Child with Learning Disabilities will meet for 10 Tuesdays from 7:30 p.m. to 9:30 p.m., starting January 26. Sponsored by the Department of Education, the course will be taught by Dr. Mary John, co-ordinator of the West Central Joint Services Program and associate at Northside Psychiatric Center. An Overview of Remedial Reading is a six-week intensive course providing an insight into some of the causes of reading failure and some approaches to overcoming these problems. Dr. John also will instruct this class on six Thursdays from 7:30 p.m. to 9:30 p.m. starting January 28.
