The School of Journalism strongly supports the proposal for new Master of Jurisprudence degree.

Many journalists produce stories daily that intersect with legal issues. Reporters cover civil and criminal trials at all levels of the court system, legislative issues, environmental issues, complexities of the health care system, and labor problems in professional sports, to name a few. As the complexities of these issues grow, there is a greater need for journalists to have the basic legal knowledge necessary to probe and analyze in order to produce accurate, fair, and balance coverage.

Also Journalists work in an environment where some understanding of the law is an absolute necessity. Knowledge of first amendment rights, the boundaries of those rights, libel laws, shield laws, and public records laws are a required part of every undergraduate journalism curriculum. Detailed knowledge of these laws permits a journalist to be more effective.

A number of our undergraduates understand the importance of this relationship, attend and complete law school, but never practice law. The M.J. degree would provide an excellent opportunity for those students to gain the expertise needed without spending the time and money required to complete the J.D.

The curriculum proposed would provide basic knowledge of the U.S. legal system while providing the flexibility for students to select specialized courses in their areas of interest. The McKinney School of Law certainly has the faculty expertise and resources to provide an excellent program.

Indianapolis is the perfect location for this degree. As the center of the state legal system, state government, and state media, and increasing importance as a center of sports and health organizations, it provides an outstanding opportunity for students of all ages to combine their expertise in these areas with a solid understanding of the law.

## Dean Roberts:

I wish to voice my support for the McKinney School of Law developing and offering a Masters of Jurisprudence Degree. I believe that such a program is needed in the Indianapolis area, and would be well received.

In my position in government relations, I deal with many State House employees, association personnel, and business leaders. They will strongly support such a program. Many of these individuals and their employees have no interest in being trial attorneys, or even going to court, at all. They would like to increase their knowledge of real estate law, contract law, health law, intellectual property law, or similar fields. To be able to pick up a Masters Degree in Jurisprudence in an area relevant to their work would be a great benefit to their futures, and such a degree could be completed in a more timely fashion.

Additionally, in my position, I work with the Indiana Commission for Higher Education on a continuous basis.
