Stephanie Nothelle Receives Darnell Medical Student Geriatrics Achievement Award



Stephanie Nothelle has received the Dr. Jeffrey C. Darnell Medical Student Geriatrics Achievement Award for 2010. The award recognizes a medical

student for outstanding service and leadership in the care of older adults and was created in 2006 to honor the founding father of geriatrics at IU, **Dr. Darnell**, for his dedication and 31 years of service to his patients and to IU Geriatrics.

Ms. Nothelle received an engraved crystal keepsake and her name has joined previous recipients on the Darnell Award perpetual plaque located in the Medical Science Building.

A third-year medical student who plans to become a geriatrician, Ms. Nothelle is the current president of the Student Geriatrics Interest Group. As the award recipient, she will attend the

American Geriatrics Society Annual Meeting in May, and as a co-author, she will present her research project entitled "Medical Students' Perspectives about Participation in a Geriatrics Elective." In the summer of 2008, she was an MSTAR - Medical Student Training in Aging Research scholar.

NAPH Cites GRACE in Medical Homes Research Brief

The National Association of Public Hospitals and Health Systems has cited the GRACE Program in its Research Brief publication, [Safety Net Hospitals Establish "Medical Homes."](#)

"This is great national recognition for Wishard and the GRACE program," notes **Steven R. Counsell, MD**, the GRACE medical director.

The February 2010 issue on safety net hospital and health system implementation of the medical home model of care provides an overview of 46 NAPH member medical home programs and identifies common characteristics of such programs.

While the medical homes are noted for sharing universal characteristics, they also are tailored to the needs of their patient populations. For example, GRACE, Geriatric Resources for Assessment and Care of Elders, attends to the needs of older adults.

The Research Brief also shares evidence from the literature about the efficacy of medical homes in improving quality of care and reducing both costs and emergency department visits, citing the randomized controlled trial results published about the GRACE Program in JAMA in 2007.

What is a "medical home?"

The National Committee for Quality Assurance, which accredits medical homes, defines the term as "*a model for care...that seeks to strengthen the physician-patient relationship by replacing episodic care based on illnesses and patient complaints with coordinated care and a long-term healing relationship.*"

follows the organization's award to the program in 2008 when Wishard's GRACE Program was honored with a NAPH Chair Award, in recognition of exceptional creative and successful work in addressing the needs of the underserved in member hospitals and health systems.

Dr. Tegeler Certified in Geriatric Medicine

Congratulations to **Monica Tegeler, MD**, a card carrying geriatrician. She passed the Certification Exam in Geriatric Medicine in late 2009.

Exam content is consistent with a pre-established blueprint developed by the Geriatric Medicine Test Committee and is reviewed and revised annually to ensure that it is current. In addition, practicing geriatricians, geriatric medicine trainees, and training program directors are surveyed periodically to provide feedback on the blueprinting process.

In 2007, the American Board of Internal Medicine elevated geriatric medicine from a certificate of added qualifications (CAQ) to a Subspecialty of Internal Medicine. Every 10 years, internists and subspecialists certified in or after 1990 renew their certificates through ABIM's Maintenance of Certification program.

Congrats to **Gene Lammers, MD, MPH**, who was recertified in geriatric medicine in 2010.




IU-CAR Annual Report Highlights Community-Based Participatory Research



The IU Center for Aging Research has published its 2008-2009 Annual Report to President McRobbie. The reports' title and theme is "Partnering in Community-Based Participatory Research."

A message from Center Director **Chris Callahan, MD**, notes the success of the center's partners--Indiana University, Wishard Health Services, and the Regenstrief Institute, Inc--in improving the quality of life for our community.

"A key reason for the success of our partners has been their ability to engage the community in defining problems and identifying solutions. IU-CAR has embraced this approach in seeking solutions to the healthcare



problems faced by older adults," adds Dr. Callahan.

The report highlights examples of IU-CAR's community-based participatory research in real-world laboratories and the networks that support these collaborations.


