# **Important Upcoming Dates**

**May 15, 2006** – Membership must be received by National FFA and paid for or guaranteed by P.O. or credit card to be considered in determination of the State Delegate count.

**June 1, 2006** – Preliminary Delegate Allocation presented to state staff for consideration. Appeals of membership counts must be submitted no later than June 10 for consideration.

**June 15, 2005** – Final Delegate Allotments presented with any approved amendments based on appeals.

**Membership Totals for 2005-2006:** The Membership Team would like to say thanks for all the hard work from state staff this year. Through April 15, 2006, we have received 448,438 members, an increase of more than 5% as compared to this time last year. States already exceeding last year's total membership include: Oklahoma, Missouri, Virginia, New Mexico, Nebraska, Montana, Florida, Kentucky, Connecticut, and Illinois.

#### 79TH NATIONAL FFA CONVENTION IN INDIANAPOLIS

**2006 National FFA Convention - State Housing Blocks:** As a friendly reminder, a \$50.00 (non-refundable) deposit per room reserved is due to the National FFA office by June 1, 2006. (Checks should be made payable to the National FFA Organization.) On May 1, you should have received an e-mail verifying your room block (room types and counts). If you have any questions, contact: Ellen Williams, ewilliams@ffa.org, 317-802-4269.

Those states and chapters not participating in the state housing block can still reserve rooms. The forms are included in the *First Edition Advisor's Planning Guide*, which were mailed April 12. The deadline for housing forms to be received at the National FFA Center is Sept. 25, 2006.

Online Convention Registration: Pre-registration for the annual national FFA convention is always your best bet to ensure your chapter obtains opening session tickets, concert tickets and entertainment options. Plus, if you've used the Indianapolis housing block, you'll save \$10 off the standard registration fee when you pre-register (on-site registrations will all be \$40, regardless of whether the group has used the housing block).

This year, pre-registering will be easier than ever before, thanks to online convention registration. Advisors nationwide will have the option to register online, seeing real-time availability of tours, National Day of Service, concerts, parking passes and rodeo tickets. You'll be able to print out a confirmation of your registration online, and, best of all, you'll receive FREE shipping and handling on your convention tickets and registration packet.

Be on the lookout for important instructions in upcoming editions of UPDATE and the **Second Edition Advisor's Planning Guide** due out in August. Of course, you can always still FAX a hard-copy registration form to the National FFA Center, but shipping and handling charges will apply to registrations submitted this way. Remember, National Day of Service and Career Success Tours will only be available through online convention registration.

Important Information regarding CDE certification and payment: We are rapidly approaching the deadline for CDE declaration forms (June 1). Several states have submitted their declaration forms, and before we start invoicing states based upon those teams, we wanted to inform all state staff of the processes that will be continued this year to ensure that declaration forms, certification forms, and payments are appropriately processed.

If your state asks the participating chapters to pay the certification fee, we would like to ask if state staff would consider having the chapters pay the state directly and then in turn have the state association pay the National FFA Organization for the total amount. We are unable to process certification forms without proper payment and we would hate to hold your teams back. Paying by one check from the state association ensures the reliability of the certification, expedites the processing time of the certification form, and ensures team orientation packets and other correspondence are sent in a timely manner. Your cooperation with this method of payment would be most appreciated.

After states send in their CDE declaration form, the National FFA Organization will invoice you for the number of teams you declared.

### The packet this invoice comes in will include four items:

- a copy of your declaration form
- an invoice based on the number of teams declared (on green paper)
- a large envelope pre-addressed to CDE Certification Coordinator at the National FFA Center (with a pink label "CDE Certification Forms/Waivers")
- a legal size envelope pre-addressed to the Accounts Receivable Department at the National FFA Center (with a green label "CDE Certification Payment")

The large envelope addressed to the CDE Certification Coordinator is for your convenience to mail any certification forms or waivers that you do not send via email.

Please use the separate, legal sized addressed to Accounts Receivable to mail the check and the voucher portion of your invoice. Please remember to include this payment voucher to ensure that payment is processed correctly. 

Please do not send this payment to the National FFA Organization lockbox in Cincinnati; as this will undoubtedly delay the certification process!

Our desire is to be pro-active in this process so that forms and checks do not get sent to the wrong places. We do not want to hold up your teams, or have them disqualified because payment was never received. Please help us help you by following the processes outlined above.
