1. Approval of Minutes

2. Seating of New Members

3. Program Development and Direction Report

Bernie Staller presented a proposal approved by the National FFA Board of Directors recommending for special project funding of a Team Ag Ed/ GLOBE initiative to provide train-the-trainer workshops for agriculture teachers to become certified GLOBE soils and hydrology trainers.

4. National FFA Foundation Sponsors' Board Report

Kent Schescke explained that the financial aftermath of the September 11th national tragedy had a major negative impact on the composition of the Foundation's Sponsors' Board. Three industry leaders serving on the Sponsors' Board are unable to continue serving on the board, including Christopher Cashman, 2003 Sponsors' Board Chairman. A process is underway by the Executive Committee to identify a replacement. Chairman Case expressed his best wishes for Mr. Cashman's future and appreciation for all the service rendered by the business leaders.

5. National FFA Foundation Office Report

Kent then gave a brief update on personnel and organizational changes of the Foundation since July 2001. Three additional FFA Foundation staff positions have been filled. Jason Givan joined the staff as Assistant Regional Director, West group working with Jim Bishop, Lynn Campbell and Janet Lewis. He most recently has worked on his family farm west of Indianapolis and has been employed as a salesman for Pioneer for the past three years. Jason holds a degree from Purdue in Soil and Crop Management.

In addition, Elbert Henderson has transitioned into the role of Assistant Regional Director, East group working with Jan Ferris, Jana Jaure and Teri Buchholtz. Elbert finished his role as Grant Writer/Grant Manager during the month of November is now fully engaged in his new role.

Kari Wallace has accepted the position of administrative assistant providing support to the West group. Kari began as a temporary employee and is now in a full staff position.

6. National Council for Agricultural Education (The Council)

Mark Leitman introduced the Council's proposals for special project funding, two of which are updates of existing instructional materials.

<u>MOTION</u>: **Moved by** Marshall Stewart, seconded Wade Miller by **and carried** to accept a special project funding request of \$247,500 for the revision of the animal welfare instructional materials. (*Attachment 3*)

MOTION: Moved by Tommy Gladden, seconded by Wade Miller **and carried** to accept a special project funding request of \$247,500 for the revision and update of food science safety and nutrition. (*Attachment 4*)

Mark thanked Kent for the work of the Foundation for programs and expressed his appreciation for the Foundation Board of Trustees' support.

7. 2002 Budget Presentation and Adoption

Marion Fletcher, National FFA Foundation Treasurer, presented the 2002 National FFA Foundation, Inc. final budget for approval.

8. National Association for Agricultural Educators (NAAE)

Sarah Osborn Welty, NAAE President-Elect, presented the report on behalf of NAAE that included the following highlights:

- ♦ 2000-01 NAAE Annual Report now online at www.naae.org as well as instructional materials for "Saving the Planet with Pesticides and Plastic" and "Risk Management in American Agriculture"
- Special thanks for Foundation for securing funding for the NAAE Pocket Diary from DeWalt
- Spring 2002 NAAE Board meeting scheduled February 6-10 in Indianapolis, IN
- ♦ 2002 NAAE Convention to be held December 10-14, 2002 in Las Vegas, NV
- ♦ \$1,000,000 appropriated for FY 2002 USDA Secondary Ag Ed Challenge Grants Program (a \$200,000 increase over FY 2001)
- ♦ School Environment Protection Act (SEPA), proposed legislation for federal law, still being actively opposed by NAAE. Legislation was kept out of the reauthorization of the Elementary and Secondary Education Act and now proponents are trying to attach their amendment to the farm bill.

9. National Postsecondary Agricultural Student Organization (PAS)

No proposals were submitted.
