Indiana University–Purdue University Indianapolis (IUPUI) invites the public to submit comments about the university in preparation for its periodic evaluation by the regional accrediting agency, the Higher Learning Commission (HLC) of the North Central Association. The regional accreditation process allows IUPUI to document that it meets the U.S. Department of Education’s standards. IUPUI must be accredited in order for our students to qualify for financial aid. Every 10 years the HLC reviews IUPUI for reaffirmation of accreditation. IUPUI will host the HLC site visit November 5–7, 2012.
